5. Screening Methodology

The screening is performed using a fuzzy matching mechanism, designed to identify potential matches between the data provided and entries present in the queried lists.

Matching criteria include:

- First and last name similarity
- Spelling variations and transliterations
- Available contextual information (country, date of birth)

The system does not rely on automatic risk scoring and does not make autonomous decisions.
